What is Protect Our Catch and what do we want to achieve?

What is it?

- **Protect Our Catch** is a campaign to ban bottom trawling in marine protected areas across the EU. It is pro-sustainable fishing, and wants to reduce the impacts of destructive fishing on marine ecosystems and local communities.

Why does it matter?

- Bottom trawling causes damage to marine ecosystems and threatens long term productivity. It diminishes fish stocks, and puts local jobs and economies in jeopardy.
- It disproportionately affects small-scale fishers and local economies reliant on sustainable practices.

Our Goal:

- To put small-scale fishing at the centre of the conversation on protected areas to ensure a sustainable and equitable future for both Europe's seas and local communities.



How are we going to achieve change?

Engaging Policymakers:

- Launching a digital and media campaign in Brussels and other EU capitals to raise awareness among decision-makers about the impacts of bottom trawling and the demands of small-scale fishers.
- Partnering with NGOs, scientists and fishers to host events, petitions, and meetings with EU policymakers.

Partnering with Fishers:

- Showcasing the voices and stories of small-scale, local fishers as champions of sustainable fishing.
- Highlighting the local impacts of bottom trawling on livelihoods, economies and communities.

Activating Public Support:

- Raising awareness in the public on the impacts of bottom trawling through the website, storytelling, digital campaigns, and testimonials.
- Mobilizing supporters across Europe to sign petitions, contact decision makers, and participate at in-person events.

We're fighting for the future of Europe's fisheries and coastal communities

European waters are the most bottom-trawled in the world, threatening the sustainability of Europe's fisheries and the families and communities of the small-scale fishers that make up the overwhelming majority of the EU fishing fleet.
